



### 2024 Economic Development Investments

- N.E. Indiana Small Business Development Center \$2,000 as SBA required match. Counseled 611 business owners, 43 new business starts, offset cost expenses to hold workshops in rural counties.
- Fort Wayne Score chapter \$2,000 for marketing, communication and promotion, mentored 428 clients, had 2910 workshop attendees and offset cost for Build Better Business Conference.
